1 Introduction

The product **Basic InformationPlus on Companies** delivers, besides updated basic information for a specific company registration number, also other trade names under which the particular business may operate as well as information on its business operations. The information comes from the Swedish Companies Registration Office and Statistics Sweden (SCB) and varies depending on the type of company.
