INTERVALL5	100 %

7 Type of control

Code	Type
------	------

ART10	The person has control through shares, participations, membership, agreement or provision in eg Articles of Association or by laws.
ART14	The person is a board member or equivalent executive.
ART17	The person represents the trustee of the foundation.
ART20	The person has the right to appoint or dispose of more than half of the board members or equivalent executives.
ART25	The person can, according to the foundation order, get an essential part of the funds distributed by the foundation.
ART30	The person has control together with related parties.
ART40	The person has control through other companies or associations.
ART70	The person is the instigator of the trust.
ART71	The person is the trustee of the trust or representative of the trustee if it is a legal person.
ART72	The person is the patron of the trust.
ART73	The person is the beneficiary of the trust.
ART74	The person exercises control in another way.
